### Limited Eligibility

The following individuals are **NOT** eligible:

- Students with **F1 Visas** in their first year (Fall & Spring semester) with Texas A&M University; They can apply in subsequent years.
- Students with **J1 Visas**.
- Students enrolled in the professional programs of veterinary medicine and law.
- Students enrolled at Texas A&M University Galveston, Texas A&M University Qatar, and the Texas A&M Health Science Center (Medicine, Dentistry, Pharmacy, Public Health, Nursing)

The following individuals **ARE** eligible

- Mexican nationals that are enrolled at the College Station campus or Texas A&M University Galveston and will be applying for the **Mexican Citizens with Financial Need Waiver** are eligible with an F1 or J1 visa.
- International undergraduate and graduate students seeking degrees from the **College Station campus**.
